1. Preparation of Application:

- a) As provided in SRO-103-86 every person seeking to possess a firearm ~~must complete application for each firearm~~. The applications can be obtained and further processing completed by the Salt River Department of Public Safety. The application must furnish all the information called for on the application form.
- b) the application must ~~provide a unmounted photograph (2x2 taken within the past year)~~ affixed in the indicated space on the form, and a completed FBI form FD-258, fingerprint card must be submitted in duplicate. The prints should be taken by qualified person. In addition, the person taking the fingerprints must enter identification data regarding the applicant.
- c) All required signatures must be entered in ink. It is preferred that the form be prepared by uses of a typewriter. Pen and ink may be used, but under no circumstances will a form filled in by use of lead pencil be accepted. All changes made on the form must be initialed and dated by the applicant.

2. Disposition of Application and payment of fees:

The applicant will forward the form to the Salt River Department of Public Safety with ~~a \$16.00 money order made payable to the Salt River Indian Community~~. This fee will cover cost of finger print processing.

If approved the form will be returned to the applicant and the Salt River D.P.S. will retain a copy.

The applicant shall not, under any circumstances carry, display, or use the firearm until the approved form is received. The form must be retained by the applicant and be available at all times for inspection by Salt River D.P.S. officers.

If the applicant is disapproved the applicant will be explained the reason for disapproval.

3. Persons Prohibited from possessing Firearms:

Under 18 USC, Chapter 44 and title VII of Public Law 90-351, as amended the following persons are prohibited from possessing a firearm, including an unserviceable firearm, which has a frame or receiver.

- (1) Fugitive from Justice (any crime)
- (2) Persons under indictment for; or who have been convicted of, a felony.
- (3) Narcotic addicts or unlawful drug users.
- (4) Persons adjudicated mental defectives or mentally incompetent; or who have been committed to any mental institution.
- (5) Veterans discharged under dishonorable conditions.
- (6) Persons who have renounced their United States citizenship.
- (7) Aliens illegally or unlawfully in the United States.
- (8) Persons under 21 years of age in the case of any firearms other than a shotgun or a firearm or a rifle and...
- (9) Persons under 18 years of age in a case of a shotgun or a rifle.
- (10) In addition an application will be denied if the possession of a firearm would place the individual in violation of the law.

4. Forfeiture/Review of Permits:

Applicant's signature authorizes the Salt River D.P.S. to investigate all statements contained in the application, misrepresentation or omission of facts called for constitutes cause to revoke, or refuse the permit. Periodic review of the application will be conducted at least every three years to maintain the integrity of the application.

Applicant must report any incident which occurs and or is covered under "Persons prohibited from possession Firearms" which may affect the validity of the permit.

If a firearm is sold, traded, given away, or otherwise disposed of the applicant must immediately report this to the Salt River D.P.S.
